The Specification, Par. [0029] Line 4, has been amended as follows: "Kanthal Kanthal."

Claim 1 has been amended as follows:

"1. A retrofit vehicular LED light base with heating means, the LED light base comprising: a planar top surface; a plurality of LEDs_mounted to the planar top surface; a plurality of cylindrical posts protruding upwardly from the planar top surface, each post defining a concave recess for receiving a flexible heating element; a flexible heating element strung around the posts, the flexible heating element roughly circumscribing the planar top surface, wherein the flexible heating element dissipates emanates heat to a housing; a thermostatic switch affixed to the planar top surface adapted to activate the flexible heating element

in response to a temperature of the thermostatic switch falling below a predetermined threshold."

Allowable Subject Matter

- 2. Claims 1-6 are allowed.
- 3. The following is an examiner's statement of reasons for allowance: The prior art of record, including that which is listed below as pertinent, fails to disclose or render obvious an LED light base comprising a planar top surface having a plurality of LEDs mounted thereon; a plurality of cylindrical posts protruding upwardly from the planar top surface, each post defining a concave recess receiving a flexible heating element which is strung around the posts; the flexible heating element roughly circumscribing the planar top surface and emanating heat to a housing; and a thermostatic switch affixed to the planar top surface adapted to activate the flexible heating element in response to a temperature of the thermostatic switch falling below a predetermined threshold as called for in the claimed combination of independent claim 1.
