THIS MATTER having come before the Court ex parte by Plaintiff's counsel pursuant to

Rule 65(b) of the Federal Rules of Civil Procedure, and the Court having considered Plaintiff's

Application for an Ex Parte Temporary Restraining Order (TRO) finds:

- 1. The Court has subject matter jurisdiction in this action;
- The generic top-level (gTLD) domain name <ezq.com> (the "Disputed Domain") has been converted by a cyberpirate from Plaintiff's domain hosting account with GoDaddy, Inc. of Arizona;
- 3. The Disputed Domain has substantial value generally and to Plaintiff specifically. Plaintiff will be irreparably harmed if he is deprived of continued use of the

Disputed Domain and/or if the Disputed Domain is resold in China as Defendant is attempting;

- 4. There is a substantial likelihood that Plaintiff will prevail on the merits of his case;
- 5. It is necessary to strip the Disputed Domain from Defendant's custody during the pendency of this case to ensure the Disputed Domain may ultimately be transferred the Plaintiff should Plaintiff prevail on the merits; and
- 6. An ex parte TRO is appropriate given the evidence before the Court.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

- That VeriSign and its agents, as the gTLD registry, change the registrar of record for the Disputed Domain <ezq.com> from its current registrar, eName in China, to the registrar of Plaintiff's counsel, GoDaddy, Inc. of Arizona ("GoDaddy"); and
- 2. That Plaintiff's counsel maintain the Disputed Domain in trust in a hosting account at GoDaddy until further ordered by the Court.
- 3. The order shall be in effect for 14 days from today's date.
